Buildings, Grounds, and Farmers Market Update

Mandy Wright-Jarrett

The WiFi has been upgraded in the last year. The new system to fast enough for the merchants to process credit card transactions and stronger for the guests. This will also allow for the HVAC system to be monitored remotely.

A Knox box will be installed for the Fire Department to be able to access keys to the campus.

The heat exchanger has been fixed. The Market paid for parts; the labor was covered by building authority.

The security and housekeeping staff will rotate every six months.

The final tally for the Fresh Bucks (extending SNAP benefits) shows that over 100 people were able to access fresh produce this Farmer's Market season. The Farmer's Market account now has about \$9,000 to be used towards next year.

Tenant Update Keisha Harrison

21/28 spaces are leased. This season tends to be slower. The Market is current with all bills – the City gave a \$250,000 grant for Market expenses. Keisha will be submitting an invoice to the City for the 2023 subsidy soon.

Greg Henneke thanked the merchants for their patience through the pandemic and the strategic planning process. The first quarter of next year will bring action on the strategic plan.

Timeline:

Phase One (now – January 2023)

- create a new vision for the Market.

Phase Two (January – May 2023)

- update the operating system.

Phase Three (TDB)

- Build out the New Market with the appropriate development.

The financial structure for the Gold Building is complete and the work should start next year. The public defenders will be moving from the Gold Building will be moving to the Justice Center. Community Corrections and other offices will be moving back to the City-County Building in the next year. Almost all of the floors of the East Wing and the Tower will be full. There will still be about 25% vacancy (old jail space and such that is hard to recover).
